QPD

- Concessionary tax regime for qualifying aircraft leasing and qualifying aircraft leasing management business in HK (DIPN 54);
- New deeming provision on profits from carrying on an aircraft leasing business or an aircraft leasing management business in HK (s.15(1)(n));
- Extend profits tax exemption to certain open-ended fund companies the central management and control of which is exercised in HK
- Introduce a two-tiered profits tax rates regime;
- Introduce a flat rate of 15% on residential property transactions executed on or after 5 November 2016, with certain exceptions;
- Extend the 15% flat AVD to acquisition of more than 1 residential property under one instrument by HK permanent residents on or after 12 April 2017.
