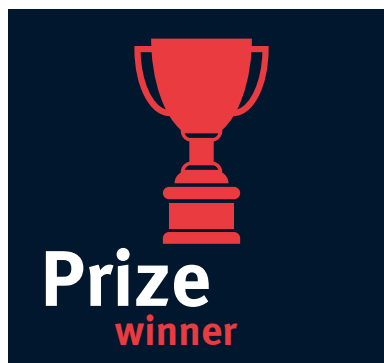

Enrolment Policy
